DUBAI VISA INFORMATION

- Minimum passport validity of 06 months
- 01 Photograph with white background required (35 x 45 mm, White background, 80% Face)
- For passengers travelling to Dubai below 25 years of age will have to provide the passport copy of one parent whose visa will have to be applied with an additional charge of INR 7500 as per Dubai Govt. rule.
- In case of visa rejection, visa fees of INR 7500/- will be non-refundable over and above the regular cancellation charges.

TERMS & CONDITIONS

- No name changes once booked
- Booking Amount will be non-refundable once booked
- Minimum booking amount is 50% of the total, per person
- Services of Experienced Tour Manager – Shall join from 1st Destination outside India. (If the group size is of 30 passengers or more)
- Pan card is mandatory to be given at the time of Booking of every passenger above 18 years, travelling outside India.
- Early check in shall not be possible.
- If tour get cancelled due to Covid Protocols or any Government restrictions, then cancellation charges would be waived off and credit note will be given to be utilized in future.

TCS TERMS AND CONDITIONS

- TCS Applicable on booking of Overseas Tour Package as per provisions of Section 206C(1G) of the Income Tax 1961
- 5% TCS on spends towards International Holiday Packages for cumulative spends (within or outside Blacksalt Overseas Consultacny) up to Rs 7 Lakhs in a financial year and
- 20% TCS for incremental spends beyond Rs. 7 Lakhs in the same financial year (Declaration to be submitted by the buyer of overseas tour program package to Blacksalt Overseas Consultacny)
- The amount of TCS paid is non-refundable in case of cancellation of tour.
- As per section 206CCA of Income Tax Act 1961, in case you have not filed your income tax returns for two preceding years; and the aggregate TDS and TCS of each tax year is INR 50,000 or more - On validating the PAN if it is found that you have not filed your Income Tax Returns for two preceding years and aggregate TCS and TCS exceeds INR 50,000, TCS @ 20% will be recovered from you or booking will get cancelled and cancellation charges will apply.
- On validating PAN - AADHAR Seeding if found not Linked, TCS will be applicable on 10% & TCS Credit might not appear in Form 26 / AIS / TIS and TCS Certificates will not be available. Also Booking will get cancelled and Cancellation charges along with 10% TCS will apply.
